



Many thanks for your interest in offering a home to a Labrador.

Initially we need to register you with us, so I am attaching an application form\*. Please complete and return the application form to me. If you email the form back to me it helps to speed the process along.

An information leaflet and a draft copy of our adoption agreement form is also attached solely for your perusal, so that you are fully aware of our conditions of adoption.

We are happy to rehome our dogs to good homes outside the areas we cover.

Once registered with us and we find a suitable dog for you, you will be required to travel to an emergency boarding kennel that we use, to meet and rehome him/her. The main kennel used is in Chessington Surrey. Should this be acceptable to you we look forward to receiving your completed prospective home form.

You need to print it out, fill it in, then scan it back into your computer and attach it to an email to return it to me.***

***Please note we will not accept other versions of this form.***

### What happens next?

When I have your completed form I will contact you and ask you to video your garden and all parts of your house that the dog will be allowed in. Please do not do this until it is requested.

- Once this has been done, passed and approved by us your registration process will be complete. At that point we will look for a suitable dog for you.
- We do not discuss details of the dogs that we have on our web site until you are registered and approved with us.

Only a few of the dogs looking for new homes are put on our web site, so don't be too disappointed if during your wait to be registered and approved, a favoured dog is reserved or removed from the web site. We nearly always have several others waiting.

After rehoming dogs for over 20 years, our experience tells us that we need a clear set of rehoming policies.

These policies are outlined below so please do read them to ensure you fully understand our rehoming criteria.

Some of the dogs we rehome are from families where they are being left for long periods due to work commitments. When the owner witnesses the dog's distress, they ask us to find their pet a home where someone will be there for him.

We expect the dog NOT to be left alone for longer than 4 hours per day. Therefore we DO NOT rehome to homes where all household members work full time or for more than 4 hours on any single day.

- We do not consider a small lunch time visit, neighbours popping in, or a dog walker sufficient cover or company for the dog being left home alone all day.
- If you own your own business and wish the dog to accompany you to work there must be a secure area for the dog to be exercised in.
- If you are an employee in a business and wish to take your dog to work with you then we will not rehome a dog to you. Many employers do not allow pets to be taken to work, and even those who do, may ultimately change their mind. You could find yourself in a position whereby you are unable to take your dog into work with you.
- We do not rehome to anyone living in a flat above ground floor. All homes and ground floor flats must have direct access to a secure garden for the sole use of the applicant.
- We will require that your property be of adequate size to house a large breed dog such as a Labrador.
- We do require all resident dogs in the home to be neutered. Unless too young.
- We do not place dogs with homes that are registered and used for childminding.
- We will not place dogs in homes that are licensed premises/public houses.
- We will not consider rehoming any of our dogs to a home where they will be used for breeding.
- We will not consider rehoming any of our dogs to a home where they will be used as a working dog.
- If you are about to move house, then you will not be able to adopt a dog until you have moved and we have all your home details and videos.
- If you are in rented accommodation we will ask to see your landlord's written permission that pets are allowed in the property.
- Military homes will be considered on an individual basis.

We have had occasions where family members wish to get a dog as a surprise companion for a newly widowed relative or for an elderly relative who has lost their aged pet. We will only place a dog with the person who will be the main carer for the dog and in the home where the dog will be living and with the full knowledge of the adopter. Therefore a rehomed dog can never be a "surprise".

**For applicants aged 70 to 74 year we will only rehome a dog of 5 yrs plus.**

**For applicants aged 75 to 80 years we will only rehome a dog of 7 yrs plus.**

**For applicants aged 80 years and over we will only rehome a dog of 10 yrs plus.**

***Please be aware that if you are applying for a bitch you will experience a wait once you are registered and approved with us. We only get around 3 in every 15 dogs coming into our rescue that are female. There is always a waiting list.***

***If you have cats in your home there will also potentially be a long wait. Only 1 out of every 10 dogs we rehome comes from a situation where they have been living with or will tolerate cats.***

## **The Homecheck**

When you return the 'Prospective Home Form' to us we will respond by asking you to video your house and garden but please do not do this until we request it. Please take a good look at your garden to make sure it is a safe environment for a dog.

- If you have any fencing that needs repairing or replacing please have this done before applying for a dog. We will not be able to rehome a dog to you unless you have a secure garden area.
- Do remember that Labradors are large dogs and will easily jump a low fence. If you have a back gate, please make sure it has a working lock or bolt.

Remember that no rescue dog is perfect; most dogs will have "baggage" which could be anything from a small training issue to insecurity and separation anxiety. Normally all that is needed is time, patience and often a good training class to turn your dog around. You will get back tenfold what you put in.

The vast majority of dogs that come into rescue are as a result of unwanted or unplanned breeding. LRRSE will require all dogs that are not neutered when they are rehomed to be neutered soon after rehoming. If your rescue dog is not already neutered we will require you to get the operation done, at your own expense. Your dog will have experienced some upheaval or stress by the rehoming experience and therefore we insist that you leave a period of at least 4 months for the dog to settle in before any neutering operation is carried out, unless on veterinary advice and with the permission of the trustees.

In signing the adoption form you will also be agreeing to the neutering clause contained in it.

## **Puppies**

- Puppies, just like babies, have special requirements.
- If you are adopting a puppy we may insist someone is at home all day.
- We will also expect you to take him or her to puppy training classes.

As previously outlined, neutering is part of the adoption agreement for your puppy and you will be required to spay or neuter your dog at the appropriate time.

**When you rehome your dog and from the moment you sign the adoption form, all financial costs, including any veterinary costs will be your responsibility.**

We pass on to you all the information the previous owner has given us about the dog, this includes any previous or current medical conditions. We cannot be held responsible if a problem is not reported to us prior to rehoming.

Where we rehome a known stray dog to you, that dog will have been assessed for a period of time in one of our foster homes or kennels and we will pass on to you any information our volunteers have discovered during the time the dog was with them. As we do not know who the previous owner was we cannot guarantee the dogs' age neither can we know of any previous behaviour issues or medical conditions.

- **We strongly recommend you insure your dog.**

For certain homes that do not fully meet our rehoming criteria the trustees may reconsider them for approval after consultation with the area coordinator.

I/We declare that in consideration of adopting the dog described above from Labrador Retriever Rescue Southern England, undertake the following:

1. Not to part with the dog for any reason whatsoever, except to return it to LRRSE
2. **Not to use the dog for breeding.**
3. Not to leave the dog on its own for more than 4 hours per day, to feed the dog adequately house it properly, exercise it regularly, keep its weight under control and provide qualified veterinary treatment in case of illness or injury..
4. To ensure that the dog is inoculated annually and wormed regularly.
5. To ensure that the dog wears a collar carrying your name, postcode and telephone number at all times for identification purposes
6. **Not to have any veterinary operation (unless emergency) performed in the first 4 months of adoption without specific agreement with LRRSE.**
7. To allow a member of LRRSE to visit the dog and repossess the dog, if in their opinion this agreement is not being adhered to.
8. To inform LRRSE when the dog dies.
9. To inform LRRSE if you move house or your contact details change.

I/We understand that:

1. LRRSE will accept no responsibility as to the description, condition, health and temperament of the dog adopted, and gives no warranty of any kind expressed or implied. The dog is believed to be in good health, except where specific conditions have been made known to me/us.

LRRSE will accept no liability for expenses incurred arising from illness or injury developed subsequent to your adoption of the dog.

2. **The responsibility for paying for the cost of any treatment from the day of adoption shall be the sole responsibility of the Adopter unless otherwise agreed with LRRSE.**

3. Information concerning the habits and past history of the dog is passed on by LRRSE in3. Information concerning the habits and past

4. LRRSE will not accept liability for any consequence whatsoever resulting from events attributable to the failure to give information or transmission of wrong information.

Labrador Retriever Rescue Southern England strongly advises all Adopters to arrange suitable insurance against the cost of Veterinary fees as well as Third Party cover. Attention is drawn to requirements relating to animals causing damage or injury to Third Party or their property and causing death or injury to livestock. The possibility for nuisance should also be recognised.

**I/WE ACKNOWLEDGE THAT THE CUSTODIAL CARE OF THIS DOG IS NOT TRANSFERABLE TO ANOTHER PERSON, SHOULD WE BE UNABLE TO KEEP THE DOG FOR ANY REASON WE MUST RETURN THE DOG TO LRRSE.**

If a rescue dog is not already neutered at the time of rehoming due to being too young or for any other reason such as illness or injury we will require the adopter to have the operation done, at their own expense, either after a period of 4 months once the dog has settled in, or by the time the dog is 12 months old. We require the adopter to send us proof of the operation having being done by providing a copy of a veterinary invoice for the procedure.

### All conditions of adoption will be followed up.

If we have any vaccination records for your dog then this paperwork will normally be posted to you within two to three weeks from the date of adoption.

**If your dog is already microchipped the details will be changed by us through the charity and you will receive an acknowledgement that this has been done. DO NOT contact the chip company to change the details WE WILL DO IT**

We will retain lifelong responsibility for that dog and should you ever be unable to keep the dog, you **MUST** contact LRRSE so that we can arrange a new home.

We **WILL** follow up **ALL** conditions of adoption and will remove the dog(s) should we find LRRSE's conditions are not being adhered to.
